Dear members,

Since the election act held at the Istambul Congress in 2014, the European Federation of Sexology (EFS) has been experiencing an unprecedented situation given the fact that the previous president of EFS (Chiara Simonelli) is acting as interim president in the current mandate while the next president (Kevan Wylie) finishes his mandate at WAS.

Such situation was already subject to debate during the congress where different ideas and opinions were expressed by the present members, all of them, naturally, with the best interest of the EFS in view.

In spite of some tension and controversy, a new executive committee (EC) was elected which has to be seen as an expression of hope and need for change in the way the EFS operates and relates with its members.

As new group, members and officers, we are happy to say that in this last year the EC worked well and with collaborative atmosphere. We are trying to identify some of the major difficulties that may have been constraining our Federation development so that we can move on in a clear and strong position. One of them is the lack of direct communication between the EC and the representatives of the affiliated societies. It is our goal to change this so that our members are more informed, feel more supported and may more easily interact with the Federation.

Another difficulty is related with some breaches in our statues that have been bringing some confusion and need to be addressed. In line with this, we have established a subcommittee that is working to amendments to the statutes, which will be presented in the next General Assembly in Dubrovnik, May 2016. The proposed document will be submitted in advance for open consultation for comments and feedback from the member societies.

In order to ensure continuity to the work we are doing and to navigate better in the transition, we have confirmed some of the proposals made in Istanbul and reasoned on the best alternative currently available. Therefore, the EC share a statement with all of our member societies and associations that is presented with <u>unanimous agreement of the committee</u>.

We have reaffirmed the decision endorsed by the General Assembly in Istanbul in January 2014 which was an emergency solution in a difficult situation. To clarify, Chiara Simonelli will remain in the role as President of the Federation for an extended period until the time of the General Assembly of the WAS in 2017 where Kevan Wylie completes his time as president of WAS. Thereafter, Kevan Wylie, current president-elect for EFS will take over as president of EFS for a reduced term of 3 years. A change will be suggested for the next statutes: there will be a limitation in time of service in the EC for officers.

In 2018, a member of the executive team will be appointed as president elect to take up the position of president from 2020.

We kindly ask to the representatives of each society and association to share this communication within his/her context of belonging, to ensure that in the next GA this issue will be clear and possibly supported. If not, it will be right to listen to other constructive proposals, brought in a structured way, namely with clear advantages with respect to the proposal presented here by this EC.

The Statute of EFS

The first statute of EFS were approved on April 27th 1991. Since then the statute have been revised in 2002 and 2006. A new revision work was started in 2010, but that proposal was never presented to the General Assembly.

A revision of the 2006 statute has been much needed in order to make the organisation more modern, more transparent and to ensure democratic processes and representation of all areas of Europe in the



Executive Committee (EC) and the officers. In 2014 a new Statute Committee was appointed by the EC, the members were Elsa Almås, Goran Arbanas, Miren Larrazabal, and Kevan Wylie. Due to different circumstances, all members have not been able to attend the meetings, and the Committee have an useful help by Antonio Palha, Trudy Griffioen and Moshe Mock.

The 2015 proposal is based primarily on the statutes from 2006 and the new proposal from 2010. The more important changes that have been suggested are:

<u>Article 2:</u> The General Secretary and the Treasurer should be separate functions.

<u>Article 3</u>: "gender" has been added among the possible areas of discrimination.

The most important changes are suggested in Article 15, where four instead of three officers are suggested: President, Vice president (President Elect), Secretary General and Treasurer. It is also suggested that there is a limitation to the time the members of the Executive Committee can serve: The members of the Executive Committee can be re-elected once, and twice if they serve in a role of the officer; three times if they are elected as president, altogether four periods as a maximum.

In <u>Article 20</u> it is suggested that the Federation should have a logo, have a website, and be presented in social media. The statute must in general be modernised and adapt to the age of electronic media, both in the formulations and in practice. This can for example mean that the time limits for suggesting issues or candidates could be shorter.

The proposed statute must be sent to the members as soon as they are ready from the committee, and be presented at the next General Assembly in Dubrovnik for approval.

EFS at the "17th Congress of the European Society for Sexual Medicine": Improving together

From 5th to 7th February 2015 the "17th Congress of the European Society for Sexual Medicine" was held in Copenhagen, Denmark in the lovely scenery of Bella Center. Goals of congress were to both deliver optimal scientific and educational programs and to promote the field of Sexual Medicine. Contents covered topics regarding sexes and all sexual orientations; in addiction to that state-of-the-art, educational opportunities and the latest innovative research had been highlighted. Over 1.250 delegates representing 65 countries all over the world had taken part and, among them, also an important delegation representing our Federation attended the event. As a result of the well-established collaboration between these societies, a joint interactive symposium took place alternating exponents of both scientific societies in very interesting speeches. Main topic was to discuss and underline novel approaches to psychotherapy in sexual medicine. Chairs were Salvatore Caruso (president of our Scientific Committee) and Paraskevi-Sofia Kirana (psychotherapist, member of ESSM educational committee and editor of "The EFS and ESSM Syllabus of Clinical Sexology"). The symposium was opened by Francesca Tripodi (EFS/ESSM) who discussed the role of biopsychosocial model in modern clinical sexology, briefly retracing its history and clarifying next goals such as implementation of collaboration between different professionals and scientific societies.

Then was the as implementation of collaboration between different professionals and scientific societies. Then was the turn of Pedro J. Nobre, who discussed the role of "Cognitive Behavioral Theory (CBT)" in sexology practice. His speech was focalized on cognitive components influencing sexuality such as sexual beliefs, automatic thoughts and cognitive schemas. In line with this theory, Marieke Dewitte focused her debate on impact of mindfulness, treatment very widespread not only in sexual therapy but in overall health psychology. Specifically her intervention regarded treatment of disorders in arousal phase. The symposium was closed by the intervention of Kevan Wylie, who explored costs and benefits of technology applied to sexual health, the so-called e-health. This symposium is the proof of a partnership that is bearing fruits already: just think about "The EFS and ESSM Syllabus of Clinical Sexology", certifications such as "EFS & ESSM Certified Psycho-Sexologist (ECPS)" and the "School of Sexual Medicine". We hope that this fruits can be grown by the next generation of young clinicians of sexual health.

such as Belgium, Italy, Malta, Romania and Turkey. The Youth committee strives to help young professionals enter the specialized field of sexology, and also motivates youth to work towards and evidence-based sexological practice. We'll keep you posted on the Committee's latest news and updates.

"University students and sexual dysfunctions: an European crosscultural survey"

Cultural values influence attitudes to sex and the perceived role of sexual activity. Relationships between different-sex partners are influenced by culturally determined gender roles, and attitudes towards sexual variation are influenced by cultural values. Cultures define what is deviant/dysfunctional and the help seeking behaviour. Childrearing through differing patterns in a culture, affects individuals' cognitive development, explanatory models of emotional distress and world views. Although epidemiological data on prevalence of sexual dysfunction across cultures are far too few, it is likely that prevalences vary, as will pathways into care and patterns of help-seeking.

Regarding sexual dysfunction in the West, the largest prevalence study in recent times is that of Shifren et al, 2008, which measured the prevalence of sexual problems in US women using the Female Sexual Distress Scale, a self-administered questionnaire on particular aspects of distress related to sex, including frustration, embarrassment and anger. The age-adjusted point prevalence of any female sexual problem was 43.1%, and 22.2% for sexually related personal distress. In a literature review of female sexual dysfunction Palacios et al, 2009, estimated that, on the basis of previously published literature in the West, 40% of women in any given country will have some sort of sexual problem, with 12–25% experiencing distress in relation to it.

More recent research in other cultures indicates higher rates. A study involving 315 Brazilian-born women in São Paulo, Brazil, Valadares et al, 2008, found a prevalence of female sexual dysfunction of 35.9%. Rates of various sexual dysfunctions in women in Turkey have also been found to be high. In one Turkish study Aslan et al, 2008, the prevalence of female sexual dysfunction, was 43% using (FSFI). The low score in the FSFI was associated with lower educational level, menopause, depression, presence of sexual dysfunction in their partner and contraceptive use. In another Turkish sample Dogan et al 2009, the most common female sexual dysfunction was vaginismus (75.9%), followed by hypoactive sexual desire (9.2%). Dyspareunia and orgasmic disorder were reported as common comorbid conditions.

In regards to men, in general the conclusions are apparent. Age is an important factor in the prevalence of ED, older men being at a larger risk of ED, than younger men. In the Massachusetts Male Aging Study (Fieldman, Goldstein, Hatzichristou, et Al, 1994, found that approximately 10% of men under 35 years of age experience ED, while the percentage grew to 50% for those over 60 years of age. Nicolosi et al, 2003, reported prevalences of erectile dysfunction of 34% in Japan, 22% in Malaysia, 17% in Italy and 15% in Brazil. In a large body of studies regarding sexual dysfunction, the aged male represents the focus and young males are often overlooked but in a recent study Christina Akre et al, 2014, on a cohort of 3,700 sexually active young males (18-25 years of age) found a prevalence of PE in 43.9% and a prevalence of ED of 51%. They did a follow-up 15.5 months later and in the meantime 9.7% developed a PE problem and 14.4% developed an ED problem.



We, the EFS Youth Committee have been tasked with a research project entitled: "University students and sexual dysfunctions: an European cross-cultural survey". Our aim is to provide a fresh and clear picture on the health situation about sexual dysfunction across a sample of between 750 and 1000 subjects, aged between 18 and 25 years old, who are attending their university studies, in their country. There are 5 different countries from Europe involved in this study: Belgium, Italy, Malta, Romania and Turkey. In addition to a quantitative study of sexual dysfunction in young people, we would like to investigate the role played by some variables and their relation like reported distress, Quality of Life (QoL) and alexithymia in this age group.

EFS YOUTH

EFS Youth Committee research project

There are a total of 5 test and a questionnaire used in the survey. The chosen tests for the survey are known to be widespread for their usage and should be found in Europe in their translated version with comparable validity and reliability as the english version. The primary tests in the study are:

- 1. The International Index of Erectile Function (IIEF) for Men,
- 2. The Female Sexual Functioning Index (FSFI) for Women,
- 3. The Toronto Alexithymia Scale (TAS20) and
- 4. The Medical Outcome Survey Short Form 36 (MOS-SF36) for the measurement of Quality of Life.

There are two more instruments for the survey that will need to be handled by the local staff in each country. One is that the last, and fifth, test used in this survey is the Sexual Complaints Screener for Men and Women, test developed by ESSM group on the basis of the EFS-ESSM Syllabus. The aim of this test for this study is to highlight the qualitative aspects about sexual satisfaction.

The other important aspect is the socio-demographic questionnaire which contains the personal data form with fields for example regarding marital status, relational situation, sexual orientation, substance use and abuse etc. and a free field left for the subject to fill in additional information that he considers important to a better understanding of his situation. Both the test and the questionnaire will be carefully translated to ensure a good understanding and comprehension in the native language by the participants.

The other important aspect is the socio-demographic questionnaire which contains the personal data form with fields for example regarding marital status, relational situation, sexual orientation, substance use and abuse etc. and a free field left for the subject to fill in additional information that he considers important to a better understanding of his situation. Both the test and the questionnaire will be carefully translated to ensure a good understanding and comprehension in the native language by the participants.

The study will be conducted online using a mother-language web-survey for each country. A commercial website dedicated to online surveying will be used (https:\\docs.google.com). Access to the survey will be done through a recruitment process that will be based on an invitation to participate in a study regarding sexual health, through passive web advertisements (banners, social networks and university networks) from which the subjects will be redirected to the survey.

This study starts this year, in 2015 and hopefully by the time of the 13th congress of the European Federation of Sexology in Dubrovnik, between the May 25th-28th of May in 2016, we will be able to provide rough data on this European cross-cultural research project.

Don't miss the next event of the Italian Federation of Scientific Sexology

The next National Congress of the Italian Federation of Scientific Sexology (Federazione italiana di Sessuologia Scientifica - FISS), will take place in Rome, at the convention center Frentani, from 3 to 5 December 2015 in collaboration with the Italian Menopause Society (SIM). The Congress, which takes place under the chairmanship of Dr. Roberta Rossi, is an important event in the Italian Sexology. In fact, FISS, has created and provide to represent in Italy an organized framework of the leading Societies in Sexology. All this through its commitment in various areas: educational, professional and scientific.

Certainly a significant contribution to overcoming the difficulties arising from the lack of a specific regulatory framework for professionals in the field of sexology, is the establishment by the FISS of a register of internal professionals. In this National Register, available http://www.fissonline.it/albo/albo.php are registered professionals from different fields (psychologists, gynaecologists, urologists, endocrinologists, psychiatrists, paediatricians) from all over the country, who work and have specialization in sexology. The element that enhances this Register is the fact that in order



to be part of it, you must have followed a training program at one of the training schools recognized by the Italian Federation, following programs that meet the educational

parameters developed by the Education Commission of the FISS. In this way the Federation not only brings together the professionals, but it offers the possibility of establishing a qualified standard.

Another important aspect of FISS is to the advancement of scientific knowledge. Just to exploit this potential in research, was created the "FISS young" with the specific objective in raising research in sexology.

The National Congress FISS is a moment of great discussion and update on the



most important issues in clinical sexology and an opportunity to receive and share data on the issues of interest on sexology in Italy.

At the next conference will be dealt with numerous issues of interest and such as "sex education in the era of the web" (social and new technologies), "the sexual behavior of young people, straight and LGB" with the contribution of the Youth Initiative Committee of the World Health Association (WAS) but also the themes of "Hypersexuality" and "Asexuality", on which the debate is still open. But also important and central themes in clinical practice, which will be given in a specific session "sexual

health and sexual medicine" within which will address the issues of integration of sexual medicine and psychology in the field of male's and female's sexual health. A further session will be devoted to the theme "Society, Culture and Sexuality", dedicated to the memory of Professor Giorgio Rifelli, one of the pioneers of sexology in Italy, will address the cultural, social and religious implications that, in different areas and stages of life can affect health sexual people.

For these propose educational program and qualification exam were set-up. For the first in history, in 2014 the ESSM congress was joint by the EFS congress and qualification examination for mark of excellence is set-up in collaboration between the ESSM and the EFS.

Eligibility criteria

The candidate eligible to take the exam must demonstrate expertise in psycho-sexology and obtain proof of

In memory of ...

Maj-Briht Bergström-Walan

A landmark in the history of sexology ended on August 25th 2014 when the news of May-Briht's demise came. For many years we had worked together in the Board of the Swedish Association for Sexology with arrangement of conferences, discussions of ethical and professional guidelines and on the importance of qualitative skills among those working as sexologists. We can all thank her for the sex education in Sweden, which became famous all around the world. Maj-Briht was a pioneer in the field, and authored several textbooks and was especially renowned for the outspoken films on The Language of Love. In addition, she participated in TV programs with another legend in the area, namely Elise Ottosen Jensen, founder of the Swedish National Association for sexuality education, RFSU.

Maj-Briht started the Swedish Sexual Research Institute and was engaged in sex therapy far longer than the usual age of retirement. "It is so important for people to have the possibility to talk to an outsider who is listening," she said about her work with people in crisis, even on Saturdays. In addition, it is certainly many of us Swedes who have read her responses of questions on sexuality in different kind of newspapers and magazines during several generations. Based on her skills as both a psychologist, midwife, sex advisor and sexologist, she became in 1996, to her great



joy and pride appointed as Honorary Doctor of Sexology at Uppsala University. Internationally, she was also noted for her work and got awarded 1997 in Valencia with the WAS Gold Medal.


In 2004 she received the EFS Gold Medal to as a mark of excellence in this field. EFS who is also grateful to her which is a kind of mother as far as a founding member.

I think that is the way May-Briht would be remembered. She loved the medals and the awards, but most of all, she enjoyed to be with her loved ones. So much joy and knowledge a single person is able to spread over a lifetime. It is empty now.

James Henderson Geer, PhD, 1932-2015



James Henderson Geer died on February 12, 2015 at the age of 82 in Lancaster, PA. He was born in Johnstown, PA on September 27th, 1932. Surviving Jim is his wife of nearly 60 years, Jean Gray Geer, and his two sons, John and David.

Graduating from the University of Pittsburgh in 1954, he went on to serve in the U.S. Air Force eventually as a First Lieutenant. He left the military to pursue a graduate degree in psychology, earning his PhD at University of Pittsburgh in 1963. In that same year, he became an Assistant Professor of Psychology at SUNY-Buffalo. Two years later he was hired by the University of Pennsylvania. In 1967, he then left the Ivy League to become an Associate Professor at SUNY-Stony Brook. Over the next 17 years, he helped to make the Psychology Department a top ten program nationally, which included a 6 year stint as chair. In 1984, Jim moved to Louisiana State University to become chair of that department and remained at LSU until his retirement in 2000. Over the course of his career, he published 72 scholarly articles, 5 books, and 15 book chapters. He secured major grants from the National Science Foundation and National Institute of Mental Health, to name a few. In 1995, he was elected President of the International Academy of Sex Research, serving in that role in 1997. His scholarship has had wide influence. In the 1960s, for example, he developed a creative way to measure fear. The original article was published in 1965 and has become a citation classic and remains influential to this day. In the 1970s, he developed a path breaking way to

measure female sexual arousal—a method that continues to serve as a central underpinning for new discoveries in the field of human sexuality. His interest in human sexuality became the defining feature of the rest of his academic career and it is those contributions that are most responsible for his substantial scholarly visibility and influence.

Jim loved new ideas and learning. He was always interested in novel arguments that marshaled compelling data in support of them. He was not much into bravado; rather he favored civil, measured exchanges based on evidence about the important debates of the day. Teaching, as a result, came natural to him. Life was always a learning experience and he sought to share those lessons whenever possible.
